

Declaration of Conformity in accordance with the REACH regulation

Declaration concerning Regulation (EC) No 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH).

As manufacturers and sellers of fastening materials, we at GREMAKO GmbH & Co. KG are only affected in our position as a downstream user or as "Products supplier".

General Obligation to Register acc. to Art. 6, 7 (1):

Registration obligations that arise on the basis of the manufacture and market introduction of substances and chemicals do not apply to us.

The products that we deliver to you are classified as articles and are therefore not defined as substances or preparations (as per Article 3 Definitions of the REACH regulation).

According to Art. 7(1) it is only necessary to register substances if they contain relevant chemicals that are also likely to be released. In the case of products that are treated with corrosion protection, substances may be released that have been registered by our suppliers. Our suppliers have provided us with the appropriate confirmations in this regard.

Duty to inform acc. to Art. 33:

Our fastening materials manufactured from C60Pb or 11SMnPb30 contain up to 0.35% **lead** (substance of very high concern, SVHC).

Other substances on the candidate list are not included in our products.

Changes in the candidate list will be reviewed.

Where necessary, we will inform you of any relevant changes made to your products on the basis of REACH, any changes to our ability to supply those products and any changes to the quality of the parts that we supply you with within the scope of our business relationship, and we will agree appropriate measures with you on a case-by-case basis.

As a downstream user, we will comply with all of the requirements imposed on us by the REACH regulation.
